# Accessibility

Bellingham has the fortune of being one of the first ports you encounter on completing the passage from the Pacific Ocean through the Straights of Juan de Fuca to Puget Sound. Our territory extends from the international border, just south of the Straights of Georgia, to Bellingham Bay. What distinguishes the Port of Bellingham is that we are free of the congestion so often found at docks and terminals serving the Vancouver (BC) and Seattle areas. In Bellingham, time consuming vessel line-ups, changing ship queues and mercurial berthing rules are never a factor. We specialize in “stress free” vessel operations at an easily accessible facility staffed by port professionals and hard-working longshore labor.

# Cargo & Trade

The Bellingham Shipping Terminal has served the ocean shipping needs of breakbulk customers since 1920. For decades the facility specialized in forest products including pulp, woodchips and logs in addition to aluminum product such as slabs and ingots. In the first years of this century industrial consolidation curtailed the movement of these base commodities from Bellingham. Fortunately, the facility was able to stay active as a center for the fabrication and domestic barging of industrial modules as well as a lay-berth site for US flag cargo ships.

Today the Port is fully committed to marine trades and over the past two years has invested over 7.5 million dollars on capital improvements including strengthening of the docks, new roofs for the warehouses, electrical & lighting upgrades and updated storm-water catchment basins. These advances have resulted in a revival of exports as well as increased import activity. Cargoes handled in recent years include Construction Materials, Organic Grains, Pulp Logs and Hardwood Logs.



# Facilities

Bellingham is a compact and efficient port. The Bellingham Shipping Terminal and our dry storage lay-down area (known as the “Log Pond”) supplement one another. The entire area is fenced, secured and under 24-hour security. If vessel cargo operations are of an international nature, MTSA regulations apply and a secondary security zone is implemented which requires a TWIC card for access. Our customers have a choice of covered or outside storage for short or long term durations. Vessels can utilize available shore power during operations. The Port is the Foreign Trade Zone grantee for our county (FTZ # 129 - Whatcom County) and on site implementation can be arranged on short notice.



## **BERTH # 1** North & Central Pier

- Length of 700 lineal feet
- Draft of 34 feet at Mean Low Water
- Heavy Cargo Section of approx. 1,900 square feet rated at 1,200 PSF

## **BERTH # 2** South Pier

- Length of 550 lineal feet
- Draft of 34 feet at Mean Low Water

## **BERTH # 3** Barge Pier

- Length of 550 lineal feet long
- Draft of 25 feet at Mean Low Water
- Available for short term Lay –Up use

## **WAREHOUSE # 1** Bordering North Pier

- Total size of 41,880 square feet
- Clear Height of 24 feet
- Office Space of 362 square feet
- Power available 480V

## **WAREHOUSE # 2** Bordering Central Pier

- Total size of 45,768 square feet
- Clear Height of 24 feet
- Office Space of 2,028 square feet
- Power available 480V



# Improvements

As part of the Bellingham Shipping Terminal revitalization the Port has made major investments in cargo handling equipment. In 2018, a joint effort between the Port and Longshoremen of ILWU Local 7 identified gear most suited to the Terminal's current and anticipated cargo needs. With the support and approval of our Commissioners funds were allocated for subsequent purchases by the Port. Our lineup now includes forklifts, terminal trucks and trailers, hopper & belt conveyor, reach-stacker and front end loader. In addition, there is a 140' certified truck scale that can be utilized for weighing cargo. Future cargo flows will dictate our next equipment acquisitions as we further strengthen the terminal infrastructure.



With this equipment the Port is able to perform a variety of cargo handling operations including:

- Receiving and loading break-bulk cargo from/to vessel.
- Receiving bulk commodities from vessel and transporting them into our warehouses.
- Loading and unloading break-bulk cargoes onto/from inbound and outbound trucks.
- Loading outbound trucks with bulk commodities stored inside our warehouses.
- Receiving project cargoes & containers from vessel and loading them onto outbound trucks.


