#### THE COMMUNITY



Sutter Creek is a welcoming and historic small city located in Amador County, California. With a population of just under 2,700 people, Sutter Creek has an active and supportive community. Its residents

take great pride in the city's history, which dates back to the California Gold Rush era. It is a place where residents and visitors alike experience the best of both worlds, with its combination of old West charm and modern amenities.

The community in Sutter Creek is known for its strong sense of civic engagement and volunteerism. Residents regularly come together to support local causes and organizations, such as the Sutter Creek Firefighters Association and the Amador County Arts Council. There are also several community events throughout the year, including the popular Sutter Creek Ragtime Festival and the Annual Christmas Open House.

The city is dedicated to preserving its history and the Gold Rush ambiance of Main Street and surrounding neighborhoods. Sutter Creek is also home to several historic landmarks, such as Miner's Bend, and the Knight Foundry - America's last water-powered foundry and machine shop. These landmarks are a testament to the city's rich history and its commitment to preserving its past.





Sutter Creek is home to a variety of businesses, including antique shops, art galleries, and restaurants. The community takes pride in supporting these local businesses, and most residents frequently shop and dine locally to support the local economy. Sutter Creek's downtown area is pedestrian-friendly, making it easy to explore. The city lies minutes from the renowned wineries and vineyards of the Shenandoah Valley, and wine tasting venues dot the downtown as well as the surrounding hillsides.

Education is also highly valued in Sutter Creek, and the city has a strong public school system. The Amador County Unified School District provides education to students from preschool through high school, and there are also several private school options in the area.

### THE CITY

The City of Sutter Creek operates under a Council-City Manager form of government, with 5 Council members elected at-large, and the Mayor elected by the Council every year. The City's annual revenues amount to \$5 million, while operating expenses total \$4.8 million. The city operates with 17.2 FTEs in departments including police, public works, finance, and administration. The City's planning and community development and engineering services are handled through contracted professional services providers. Fire services are provided by the Sutter Creek Fire Protection District.

#### THE DEPARTMENT & POSITION

The Sutter Creek Public Works Department is responsible for maintaining the city's infrastructure and providing essential services to the community. With an annual budget of \$2.3 million, the department employs 5 FTEs to manage a range of services including streets and roads, sewer, parks and facilities, and the City operates its own Wastewater Treatment Plant. The City contracts with the Amador Water Agency to ensure that the community's water needs are met, and contracts with a local refuse and recycling company to manage the collection and disposal of waste throughout the city.

Under the direction of the City Manager, the Director plans, organizes, directs, and reviews the activities and operations of the Public Works Department, including supervision and review of work of works staff and outside consultpublic ants/contractors. The successful candidate will also oversee operation and maintenance of streets and roads, parks, city-owned facilities, and wastewater system, as well as coordinate activities with other City departments and outside agencies; provide highly responsible and complex administrative support to the City Manager, and act as a member of the City management team.
